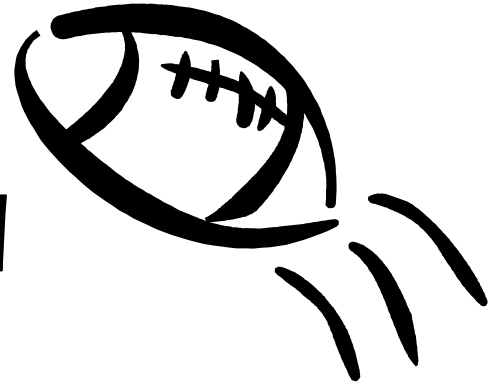




# Elementary Flag Football Skills Clinics
