### **CAMP CONTENT:**

Off Season Football Strength and Speed Camp is designed for all athletes, especially athletes interested in playing football. Future 9<sup>th</sup> graders (Freshman Class of 2018) are encouraged to attend the Summer Camp beginning Monday June 11<sup>th</sup> at 5-7:30pm. The cost is the same - \$85. There will be an incoming **Freshman parent meeting Tuesday, June 12, 2018, from 7pm - 8pm** in the Del Campo ACC Room to meet the coaches and answer questions.

Spring Football Strength and Speed Camp will begin for JV and Varsity players in May. Much of the past success Del Campo Football Program has enjoyed is attributed to this off season Football, Speed, and Strength Camps. In addition to speed and strength development, athletes will be instructed on the proper fundamentals and techniques of football. Additionally, athletes will occasionally work on football skills associated with 7 on 7 Passing Practice with other schools.

Explosive speed and strength will be developed through Olympic and Power free-weight lifting, upper and lower body plyometrics, medicine ball training, agility drills, and proper sprinting and jumping mechanics. Athletes will be tested regularly and the results will be monitored and tracked. Program workouts are specifically designed for every day attendance. Athletes committed to every day attendance will run faster, jump higher, and will become stronger.

### **CAMP COORDINATOR:**

Mike Dimino, the Head Football Coach at Del Campo High School, along with his staff, will work closely with the athletes in all aspects of the football and training. The Del Campo Varsity Football Team has won the CIF Section Championship twice and has gone to the playoffs for 12 of the last 14 years. Due to a strong emphasis in academics and weekly grade checks, the Del Campo Football Program has produced 36 collegiate and two NFL football players from 2003 to 2016, one of the most in the Sacramento Area.
