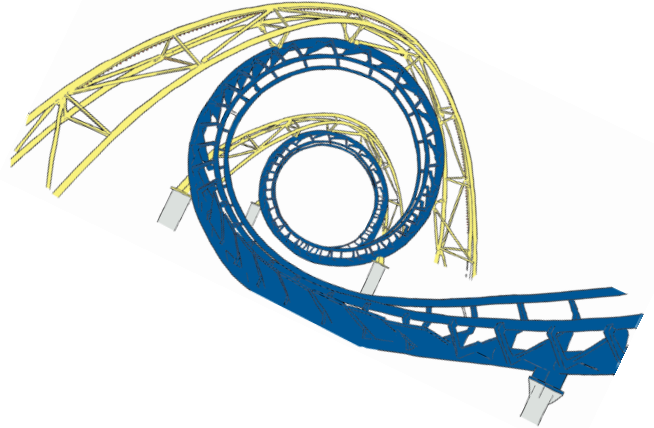

Kids, are you ready for thrilling roller coasters and amazing animals? Our Six Flags Discovery Kingdom trip is open to all children ages 5 to 14 years old.

Do you already have a season pass? Well you can still sign-up! Check out the fees below.
Space is limited so please register early.

DATE/TIME: Wednesday, July 11th 8:00am—6:00pm

BRING: Children should bring money for any food, drinks, etc to be purchased throughout the day. Children's money should be placed in an envelope with their name on it. Staff will hold onto the envelopes while at the park for the children.

We will have the children eat any snack or lunch when we arrive at the park so please bring a lunch in a paper bag and drinks in a plastic or canned containers.

Be sure your child has sunscreen on and brings some with him/her.

Our leaders will have a back pack to store items but we recommend for children not to bring a bag because most rides do not allow bags causing children to have to purchase a locker for the day.

FEE: \$85 (Resident) \$90(Non-Resident) per participant
\$75 per participant if enrolled in our summer camps
\$55 per participant if they already have a season pass
Fee includes ticket, transportation and supervision
