Subject: POP STAT PROGRAM – Monthly Report

The Monthly Activity Report for the park police that patrol District Parks during the month of May 2024 is attached. The District receives patrol services under contract with the Fulton El Camino Recreation and Park District Police Department.

The District has access to information online.

Codes – referenced in the Report during this reporting period with no description.

CA Vehicle Code referenced in the Reporting Period, follows:

4000(a) (1) A person shall not drive, move, or leave standing upon a highway, or in an off street public parking facility, any motor vehicle, trailer, semitrailer, pole or pipe dolly, or logging dolly, unless it is registered and the appropriate fees have been paid under this code or registered under the permanent trailer identification program, except that an off-highway motor vehicle which displays an identification plate or device issued by the department pursuant to Section 38010 may be driven, moved, or left standing in an off street public parking facility without being registered or paying registration fees.

22450(a) The driver of any vehicle approaching a stop sign at the entrance to, or within, an intersection shall stop at a limit line, if marked, otherwise before entering the crosswalk on the near side of the intersection.

If there is no limit line or crosswalk, the driver shall stop at the entrance to the intersecting roadway. (Amended by Stats. 2007, Ch. 630, Sec. 8. Effective January 1, 2008.)

22500.1 In addition to Section 22500, no person shall stop, park, or leave standing any vehicle, whether attended or unattended, except when necessary to avoid conflict with other traffic or in compliance with the directions of a peace officer or official traffic control device along the edge of any highway, at any curb, or in any location in a publicly or privately owned or operated off-street parking facility, designated as a fire lane by the fire department or fire district with jurisdiction over the area in which the place is located.

The designation shall be indicated (1) by a sign posted immediately adjacent to, and visible from, the designated place clearly stating in letters not less than one inch in height that the place is a fire lane, (2) by outlining or painting the place in red and, in contrasting color, marking the place with the words "FIRE LANE", which are clearly visible from a vehicle, or (3) by a red curb or red paint on the edge of the roadway upon which is clearly marked the words "FIRE LANE". (Amended by Stats. 1984, Ch. 129, Sec. 1. Effective May 21, 1984.)

Sacramento County Codes referenced in the Reporting Period:

9.36.050 Failure to Obtain Required Permit.

No person shall use, occupy, or otherwise remain in any park facility or portion thereof for which a permit is required without first having obtained such permit. (SCC 36 § 2, 1971.)

9.36.061 Animals.

- a. No person shall:
- 4. Bring into, maintain or allow in or upon any park facility any dog, cat, or other animal except a horse, unless such animal at all times is kept on a leash of sufficient strength and durability that it cannot be broken by the animal so leashed, and no longer than six feet in length, and be under the full and complete physical control of its owner or custodian at all times. Notwithstanding the provision of this subsection (a)(4), the Director may designate:
- i. Areas and times where such animals may be unleashed for purposes of show, demonstration, or training,
- ii. Areas and times where such animals are wholly restricted from entering designated parks or park areas;

9.36.065 Motorized Vehicles.

D. No person shall park any automobile, Class 3 electric bicycle as defined by California <u>Vehicle</u> <u>Code</u> section 312.5, motorized bicycle or moped as defined by California <u>Vehicle Code</u> section 406, or other motorized vehicle within any park facility except in areas specifically designated as parking areas. In no case shall any person park a motorized vehicle in a manner that presents a hazard to the public.

9.36.066.6 Prohibition of Carts in Park Facilities.

Within the boundaries of the American River Parkway no person shall use a shopping cart, basket that is mounted on wheels or a similar device that is primarily used for the purpose of transporting goods of any kind.

(SCC 1314 § 1, 2005)

10.24.030 No Parking Zones.

- a. The Director is authorized to prohibit stopping, standing or parking on any highway or may prohibit stopping, standing or parking during certain hours of the day on any highway.
- b. When signs authorized by provisions of this section are in place, giving notice of the provisions thereof, no person shall stop, stand/or park any vehicle contrary to the directions and provisions of such signs. (Ord. 703 § 60, 1960.)
